

ORDINANCE NO. 1715

**AN ORDINANCE AMENDING THE 1996 ADOPTED BUDGETS FOR THE CITY OF EUREKA SPRINGS, ARKANSAS, FOR THE REMAINING 6 MONTH PERIOD BEGINNING JULY 1, 1996, AND ENDING DECEMBER 31, 1996; APPROPRIATING MONEY FOR EACH AND EVERY ITEM OF EXPENDITURE THEREIN PROVIDED FOR; DECLARING AN EMERGENCY TO EXIST; AND FOR OTHER PURPOSES**

**WHEREAS**, The City Council of the City of Eureka Springs, Arkansas, has made a comprehensive study and review of the proposed amended budgets; and,

**WHEREAS**, in the opinion of the City Council, the proposed amended 1996 Budgets present as accurately as possible the City's anticipated revenues and expenditures for the remainder of the 1996 calendar year; and,

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EUREKA SPRINGS, ARKANSAS, THAT:**

Section 1. This Ordinance shall be known as the Amended Budget Ordinance for the City of Eureka Springs, Arkansas, for the remaining budget period beginning July 1, 1996, and ending December 31, 1996; and the attached budget documents present the estimated revenues and expenditures for the period. All revenues and appropriations are estimated; all appropriations are based on estimated revenues; and all estimates are subject to change during the budgetary period.


Section 2. The amounts for each expenditure classification proposed in the amended 1996 City Budgets are hereby approved by the City Council of the City of Eureka Springs, Arkansas; and they are hereby authorized and appropriated for the purposes set forth for the remainder of calendar year ending December 31, 1996.

Section 3. Repeal Clause: All Ordinances or Resolutions, and parts thereof, in conflict herewith are hereby repealed to the extent of such conflict.


Section 4. Emergency Clause: Since planned, approved amended budgets are necessary for the efficient operations of Municipal Government beginning July 1, 1996, an emergency is hereby declared to exist; and since approval of the amended 1996 Budgets is necessary for the preservation of the public peace, health, and safety and the continuance of public services, this Ordinance shall take effect and be in force from and after its passage and approval.
