

**ORDINANCE No. 2181**

**AN ORDINANCE AMENDING EUREKA SPRINGS MUNICIPAL  
CODE TITLE 4**

**WHEREAS**, the City Council of the City of Eureka Springs, Arkansas, has reviewed the current code provisions related to taxicabs; and,

**WHEREAS**, it has been determined that it is in the best interests of the City to amend the Municipal Code;

**NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EUREKA SPRINGS, ARKANSAS:**

**SECTION 1.** That 4.32.01 is hereby amended to add the following definitions:

**Jumbo taxicab** means a motor-driven vehicle with seating capacities not exceeding eighteen (18) passengers used in a like manner as a taxicab by a holder of a taxicab certificate of public convenience. A holder of a taxicab certificate of public convenience may request that one (1) or more of his or her vehicles be designated as a jumbo taxicab for use under the authority of the holder's certificate by so listing the vehicle(s) with the City Clerk.

**Limousine** means any other passenger automobile or van, not herein otherwise defined, with seating capacities not exceeding eighteen (18) passengers used to transport passengers for hire; which, does not operate over regular routes having fixed termini or upon regular schedules of operation. Limousines may only be dispatched or otherwise hired with no less than a two hour waiting period prior to pickup of passenger(s). It shall be a violation of this article to operate a limousine with a pickup location within the municipal corporate limits of Eureka Springs, Arkansas without compliance with the minimum two hour waiting period between hire (dispatch) and pickup.

**SECTION 2.** Severability Clause: In the event that any section, subsection, paragraph, subdivision, clause, phrase or other provision or portion of this Ordinance shall be adjudged invalid or unconstitutional, the same shall not affect the validity of this Ordinance, code section or chapter as a whole, or any part or provision other than the part so decided to be invalid or unconstitutional, and the remaining provisions of this Ordinance, Code, code section or chapter shall remain in effect.

**SECTION 3.** Repeal Clause: All Ordinances, Resolutions, and parts thereof, in conflict herewith are hereby repealed to the extent of such conflict.
