

ORDINANCE NO. 1803

AN ORDINANCE CALLING A SPECIAL ELECTION IN THE CITY OF EUREKA SPRINGS, ARKANSAS ON THE QUESTION OF APPROVING A MEMORANDUM OF UNDERSTANDING AND CONTRACT PROVIDING FOR CONSTRUCTION, MAINTENANCE, OPERATION AND EXPANSION OF THE CARROLL-BOONE WATER DISTRICT WATER SUPPLY FACILITIES; AND AUTHORIZING THE EXECUTION AND DELIVERY THEREOF; AND PRESCRIBING OTHER MATTERS PERTAINING THERETO.

WHEREAS, a referendum petition was filed on Ordinance Number 1791 and duly certified by the Eureka Springs, Arkansas, City Clerk.

WHEREAS, the purpose of this Ordinance is to call a special election on the measure.

NOW THEREFORE BE IT ORDAINED by the City Council of the City of Eureka Springs, Arkansas:

SECTION 1. There be, and there is hereby called a special election to be held on November 24, 1998 at which election there shall be submitted to the electors of the City of Eureka Springs the question of the memorandum of understanding and the contract providing for the construction, maintenance, operation and expansion of the Carroll-Boone Water District Water Supply Facility.

SECTION 2. The question of the passage of Ordinance No. 1791 shall be incorporated into the ballot for the special election to be held on November 24, 1998 in substantially the following form:




