

AN ORDINANCE AMENDING CHAPTER 7.36 , EUREKA SPRINGS MUNICIPAL CODE, BY MAKING THE APPLICATION CONTENTS REQUIREMENTS THEREIN CONSISTENT WITH THOSE OF CHAPTERS 7.32 AND 7.40, EUREKA SPRINGS MUNICIPAL CODE, AND BY DELETING THE REQUIREMENT THAT AN APPLICATION FOR A LICENSE FOR THE SALE OF LIGHT WINES AND BEER MUST RECEIVE APPROVAL BY THE CITY COUNCIL PRIOR TO THE ISSUANCE OF SUCH LICENSE BY THE CLERK/TREASURER.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EUREKA SPRINGS, ARKANSAS:

Section 1. Section 7.36.02, Eureka Springs Municipal Code, amended

Section 7.36.02, Eureka Springs Municipal Code, is hereby amended to read, in its entirety, as follows, to-wit:

7.36.02 Application; state permit. Before any person shall engage in the business of serving or selling light wines and/or beer for on-premises or off-premises consumption, an application shall be made to the Clerk/Treasurer for the granting of a license.

Said application shall contain a sworn statement of the name of the business sought to be licensed, the names and addresses of all the persons owning, managing or holding any interest in said business, and the owner or owners of the building or premises in which said business is to be located, and shall be accompanied by the applicant's state permit for said business. Upon finding that said application and said state permit are in order, the Clerk/Treasurer shall issue said license and return said state permit to the applicant upon payment of the license fee provided in this chapter and upon compliance with all other requirements of law related to operation of said business.

Section 2. Section 7.36.04, Eureka Springs Municipal Code, amended

Section 7.36.04, Eureka Springs Municipal Code, is hereby amended by causing the introductory portion thereof to read, in its entirety, as follows, to-wit:

7.36.04 Fees for license. Any person who shall

apply for and receive a license for the business of serving or selling light wines and/or beer for On-premises or off-premises consumption shall pay to the city an annual privilege tax according to the following schedule:
