ORDINANCE NO. 1180

AN ORDINANCE AMENDING SUBSECTION 4.40.04 (b)(2) EUREKA SPRINGS MUNICIPAL CODE, FOR THE PURPOSE OF MODIFYING THE MAXIMUM RATES WHICH MAY BE CHARGED BY A LICENSEE LICENSED BY THE CITY OF EUREKA SPRINGS, ARKANSAS, TO ENGAGE IN THE BUSINESS AND OPERATION OF COLLECTING SOLID WASTES.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EUREKA SPRINGS, ARKANSAS.

Section 1. Subsection 4.40.04 (b)(2), Eureka Springs Municipal Code, amended.

Subsection 4.40.04 (b)(2), Eureka Springs Municipal Code, is hereby amended to read in its entirety, as follows, to-wit:

"(b)(2) Maximum monthly charges for commercial service sites generating a high volume of solid wastes and storing the same on their respective premises in high volume containers approved by the licensee and maintained on the premises of the service sites at locations accessible to the collection vehicles of the licensee and approved by the licensee shall be \$2.00 per cubic yard of solid wastes collected by the licensee or in accordance with the following schedule, to-wit:
