

ORDINANCE NO. 1195

AN ORDINANCE AMENDING SECTION 7.40.06.  
EUREKA SPRINGS MUNICIPAL CODE, PROVIDING  
FOR THE HOURS OF SALE OR OPERATION OF  
ESTABLISHMENTS OFFERING ON-PREMISES CON-  
SUMPTION OF ALCHOLIC BEVERAGES.

BE IT ORDAINED BY THE CITY COUNCIL OF THE  
CITY OF EUREKA SPRINGS, ARKANSAS

SECTION 1. Section 7.40.06., Eureka Springs Municipal Code,  
amended.

The second full paragraph in Section 7.40.06, Eureka Springs  
Municipal Code, is hereby amended to read in its entirety as follows:

- (b) It shall be unlawful for any person to sell, offer for sale or giveaway at retail any spirituous, vinous, malt or intoxicating alcholic liquor after the hour of \_\_\_\_\_ o'clock \_\_\_\_ .m. [midnight] or before the hour of eight o'clock a.m. Provided, however, on Saturday [Sunday] all sales shall cease by \_\_\_\_\_ o'clock midnight [\_\_\_\_ a.m.]
- (c) Private clubs operating in accordance with permits issued pursuant to Arkansas Statutes § 48-1410 may serve alcholic beverages at all times except between the hours of 2:00 a.m. Sunday and 8:00 a.m. Monday. [Sunday]
- (d) Hotels and restaurants selling alcholic beverages for on-premises consumption in accordance with permits issued pursuant to Arkansas Statutes § 48-1405 may sell alcholic beverages for on-premises consumption until \_\_\_\_\_ o'clock \_\_\_\_\_ .m. on Sunday, provided that there shall be no sales of any alcholic beverages by such business establishments between the hours of \_\_\_\_\_ o'clock \_\_\_\_ .m. on Sunday and 8:00 o'clock a.m. on Monday.
- (e) Notwithstanding the provisions of this section, the sale of alcholic beverages may be made from 12:01 a.m. until \_\_\_\_ a.m. on each New Year's Day.

SECTION 2. Section 7.40.06, Eureka Springs Municipal Code,  
amended.

The fourth line of the third full paragraph of Section 7.40.06, Eureka Springs Municipal Code is amended as follows:

... the hours prohibited by this section shall be ...

SECTION 3. Section 7.40.06, Eureka Springs Municipal Code,  
amended.

The first and third paragraphs of Section 7.40.06, Eureka  
Springs Municipal Code are designated (a) and (f) respectively.
