

ORDINANCE NO. 1216

AN ORDINANCE LEVYING A TAX ON ALL
REAL AND PERSONAL PROPERTY IN THE
CITY OF EUREKA SPRINGS, ARKANSAS;
AND DECLARING AN EMERGENCY

BE IT ORDAINED BY THE CITY COUNCIL
OF EUREKA SPRINGS, ARKANSAS, THAT:

SECTION 1. LEVY OF PERSONAL PROPERTY

A tax of 5.2 mills on the dollar is hereby levied on all personal property situated within the corporation limits of the City of Eureka Springs, Arkansas for the following purposes:

1-General Fund .0043
2-Fireman's Relief & Pension Fund .0009

SECTION 2. LEVY ON REAL PROPERTY

A tax of 2.8 mills on the dollar is hereby levied on all real property situated within the corporate limits of the City of Eureka Springs, Arkansas for the following purposes:

1-General Fund .0025
2-Fireman's Relief & Pension Fund .0003

SECTION 3. COLLECTION

The 5.2 mills above levied on the personal property are to be collected at the regular collection of taxes by the Collector of Carroll County, Arkansas, at the same time and in the same manner that State and County taxes are collected for the year 1985.

The 2.8 mills above levied on the real property are to be collected at the regular collection of taxes by the Collector of Carroll County, Arkansas, at the same time and in the same manner that State and County taxes are collected for the year 1985.

SECTION 4. EMERGENCY

It has been found and is hereby declared, that a levy and collection of taxes is necessary for the continuance of municipal services to the residents of Eureka Springs, and for the preservation of the public health, safety, and general welfare, and an emergency is hereby declared to exist and is so declared, whereby this Ordinance shall be in effect from and after its passage, approval, and publication as provided by law.


