

ORDINANCE NO. 1277

AN ORDINANCE AMENDING CHAPTER 11.04.03(4) OF THE EUREKA SPRINGS MUNICIPAL CODE, FOR THE PURPOSE OF INCREASING THE SCHEDULES OF FEES TO BE APPLIED BY THE CITY OF EUREKA SPRINGS, ARKANSAS, WITH RESPECT TO PERMITS GRANTED FOR THE ERECTION, BUILDING OR CONSTRUCTION OF NEW BUILDINGS AND THE ENLARGEMENT, ALTERATION, REPAIR, CONVERSION, REMODELING, RENOVATION OR RESTORATION OF EXISTING BUILDINGS

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EUREKA SPRINGS, ARKANSAS:

Section 1. Section 11.04.03(4) (a), Eureka Springs Municipal Code, amended.

Section 11.04.03 (4) (a), Eureka Springs Municipal Code, is hereby amended to read, in its entirety, as follows:

(a) Subsection 107.4(2) of this Code is hereby amended, in its entirety, to read as follows:

An applicant for a permit to erect, build or construct a new building or buildings and an applicant for a permit to enlarge, alter, repair, convert, remodel, renovate and/or restore an existing building or a part or parts thereof shall tender with the application a fee for the permit based on the total valuation of the proposed project in accordance with the following schedule, to wit:

<u>TOTAL VALUATION</u>	<u>FEE</u>
Under \$100.00	No fee, unless inspection required, in which case a \$5.00 fee for each inspection shall be charged.
\$101.00 to \$1,000.00	\$10.00
\$1,001.00 to \$2,000.00	\$15.00
\$2,001.00 to \$15,000.00	\$15.00 for the first \$2,001.00 plus \$4.50 for each additional thousand or fraction thereof, to and including \$15,000.00
\$15,001.00 to \$50,000.00	\$73.50 for the first \$15,001.00 plus \$3.50 for each additional thousand or fraction thereof, to and including \$50,000.00
\$50,001.00 to \$100,000.00	\$196.00 for the first \$50,001.00 plus \$2.75 for each additional thousand or fraction thereof, to and including \$100,000.00
\$100,001.00 to \$500,000.00	\$333.50 for the first \$100,000.00 plus \$1.75 for each additional thousand or fraction thereof, to and including \$500,000.00
\$500,001.00 and up	\$1,003.50 for the first \$500,001.00 plus \$1.25 for each additional thousand or fraction thereof.

Section 2. Severability



Section 3. Repeal


All portions of minute orders, resolutions and ordinance in conflict with any portion of this ordinance are hereby repealed.
