

ORDINANCE NO. 1617

**AN ORDINANCE AMENDING CHAPTER 10.04, WATER RATES, OF
THE CITY OF EUREKA SPRINGS, ARKANSAS,
MUNICIPAL CODE**

WHEREAS, the City Council has carefully reviewed the current rates for resident and nonresident consumers of the Municipal Water System; and,

WHEREAS, the City Council finds that water rates should be amended.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EUREKA SPRINGS, ARKANSAS, THAT:

Section One: Water Rates Amended

a. Section 10.04.02 of the Municipal Code is hereby amended to read:

The City Council hereby finds and declares the following monthly rates and charges for Water usage fair, reasonable, and necessary; and they are hereby fixed on the effective date of this Ordinance:

	<u>Inside City Limits</u>	<u>Outside City Limits</u>
First 2,000 gallons of water consumption per month or portion thereof.....	\$6.00 (minimum)	\$12.00 (minimum)
Next 8,000 gallons of water consumption per month or portion thereof.....	\$2.20 per 1,000 gallons	\$4.40 per 1,000 gallons
Over 10,000 gallons of water consumption per month or portion thereof.....	\$3.00 per 1,000 gallons	\$6.00 per 1,000 gallons

Section Two: Repeal Clause

All Ordinances or Resolutions, and parts thereof, in conflict herewith are hereby repealed to the extent of such conflict.

Section Three: Emergency Clause

~~The City Council of the City of Eureka Springs, Arkansas, finds that some of the current water rates are no longer adequate to support the operation, management, maintenance, improvement, and expansion of the Municipal Water System; that some rates must be increased in order to insure public health, safety, and welfare; and that an emergency is hereby declared to exist.~~
