

ORDINANCE NO. 1650 (AMENDED)

AN ORDINANCE AMENDING CHAPTER 8.16, PARKING, SECTION 8.16.06-2, PROVISIONS, OF THE MUNICIPAL CODE AND ESTABLISHING WEEKEND AND NIGHTTIME PARKING IN CERTAIN LOADING ZONES

WHEREAS, the City Council of the City of Eureka Springs has determined that certain previously established loading zones within the City should be utilized for weekend and nighttime parking in order to make more parking spaces available in downtown Eureka Springs; and,

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EUREKA SPRINGS, ARKANSAS, THAT:

Section One: Paragraph To Be Added to Section 8.16.06-2

a. Paragraph 52 shall read: Certain loading zones shall be utilized for vehicular parking without charge from 6 p.m. to 6 a.m. Mondays through Thursdays and 6 p.m. Fridays through 6 a.m. Mondays as follows:

1. Three (3) parking spaces in the 60' loading zone on the East side of Spring Street North of the intersection of Spring and Main Streets.
2. Three (3) parking spaces in the 68' loading zone on the East side of Spring Street at the intersection of Spring and Center Streets, located in the area of 19 Spring Street.
3. Two (2) parking spaces in the 37' loading zone on the West side of Spring Street, located just North of the fire hydrant/No-Parking Zone in the area of 44 Spring Street.
4. Two (2) parking spaces in the 47' foot loading zone on the West side of Spring Street, located in the area 78 Spring Street.
5. Three (3) parking spaces in the 66' loading zone on the West side of Spring Street beginning at the corner of Mountain Street.
6. Two (2) parking spaces in the 38' loading zone on the East side of Spring Street located in front of 123 Spring Street.

Section Two: Paragraph 16, Section 8.16.06.02, To Be Amended

Paragraph 16, Section 8.16.06.02, shall be amended to read:

16. The 10-minute, white parking zone on the East side of Spring Street located in front of 99 Spring Street and the U.S. Post Office shall extend 117'.

Section Three: Repeal Clause

All Ordinances or Resolutions, and parts thereof, in conflict herewith are hereby repealed to the extent of such conflict.
