

**ORDINANCE NO. 1694**

**AN ORDINANCE AMENDING CHAPTER 8.20, "PARKING METERS," OF THE  
MUNICIPAL CODE**

**WHEREAS**, the City Council of the City of Eureka Springs has determined that certain provisions of Chapter 8.20, "Parking Meters," of the Municipal Code, should be amended; and,

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EUREKA SPRINGS, ARKANSAS, THAT:**

**Section One: Section 8.20.04, "Violations," To Be Amended**

Paragraph two of Section 8.20.04, "Violations," shall be amended to read:

Said parking space may then be used by such vehicle during the legal parking limits from 9 A. M. to 6 P. M. daily including weekends and holidays. Said vehicles shall be considered as unlawfully parked if it remains in said space beyond the legal parking limit and/or when such illegally parked. It shall be unlawful for any person to cause or permit any vehicle to be unlawfully parked as set out in this section.

**Section Two: Section 8.20.06, "Courthouse Parking Cost," To Be Amended**

Paragraph (a), Section 8.20.06, shall be amended to read:

(a) Courthouse Parking Cost on Lot #1: Any person desiring to park any vehicle within a parking meter space on the "Courthouse Parking Lot # 1" (south side ) shall deposit the proper coins for the time desired as follows:

Thirty Minutes	\$0.50
One Hour	\$1.00
One & half hours	\$1.50
Two hours	\$2.00

Exception: Meters designating Twenty Minute Police & Courthouse Business, shall be limited to \$0.25.

Paragraph (b), Section 8.20.06, shall be amended to read:

(b) Parking Lots owned or managed by the City of Eureka Springs: Any person desiring to park any vehicle within a parking space on any parking lot owned or managed by the City of Eureka Springs, between the hours of 9: A. M. and 6: P. M daily , shall deposit the proper fee in the Lot Parking Box, as said fee shall be displayed on the parking box.

Paragraph (c), Section 8.20.06, shall be amended to read:

(c) Other Parking Metered Areas: Any person desiring to park any vehicle within

a parking meter zone, between the hours of 9: A. M. and 6: P. M. daily, shall deposit the proper coins for the time desired as follows:

Thirty Minutes	\$0.50
One hour	\$1.00
One & half hours	\$1.50
Two hours	\$2.00

**Section Three: Repeal Clause**

All Ordinances or Resolutions, and parts thereof, in conflict herewith are hereby repealed to the extent of such conflict.
