

ORDINANCE NO. 857

AN ORDINANCE ENTITLED "AN ORDINANCE ACCEPTING THE ANNEXATION OF THE MILES ADDITION TO THE CITY OF EUREKA SPRINGS, ARKANSAS, AND ESTABLISHING SAID MILES ADDITION AS A PART OF WARD NO. ONE (1) OF SAID CITY".

BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF EUREKA SPRINGS, ARKANSAS, TOWIT:

WHEREAS, on the 15th day of April, 1965, the County Court of Carroll County, Arkansas, did make an order annexing certain property therein described and referred to as the Miles Addition to the City of Eureka Springs, Arkansas; and,

WHEREAS, thirty (30) days have elapsed since that time with no suit having been filed in the Circuit Court for the Western District of Carroll County, Arkansas, to have the annexation prevented; and,

WHEREAS, it is the desire of the City Commission of the City of Eureka Springs, Arkansas, to annex said Miles Addition to the City of Eureka Springs, Arkansas, and to designate said Miles Addition as a part of Ward One (1) of said City.

NOW, THEREFORE, the City of Eureka Springs, Arkansas, by and through its duly elected and qualified City Commission, does hereby annex the said Miles Addition to the City of Eureka Springs, Arkansas, and from this day forth, the said Miles Addition shall be a part of the corporate limits of the City of Eureka Springs, Arkansas; furthermore, that said Miles Addition shall become a part of Ward No. One (1) of said City.

All ordinances or parts thereof conflicting with any provision of this ordinance are hereby repealed.

It is hereby further Ordered that the plat of said Miles Addition be filed with the Clerk of the Western District of Carroll County, Arkansas, forthwith, and reference is hereby made to said plat for the accurate boundaries of the Miles Addition to the City of Eureka Springs, Arkansas.


