

ORDINANCE NO. 914

AN ORDINANCE ACCEPTING THE ANNEXATION OF CERTAIN TERRITORY CONTIGUOUS TO THE CITY OF EUREKA SPRINGS, ARKANSAS, AND ESTABLISHING SAID TERRITORY AS A PART OF WARD NO. ONE (1) OF SAID CITY.

WHEREAS, on the 30th day of October, 1969, the County Court of Carroll County, Western District, Arkansas, entered an order annexing the hereinafter described territory to the City of Eureka Springs, Arkansas; and,

WHEREAS, more than thirty (30) days have elapsed since the date of said order and that no suit or other proceedings have been filed in the Circuit Court for the Western District of Carroll County, Arkansas, to prevent said annexation; and,

WHEREAS, it is the desire of the City Council of the City of Eureka Springs, Arkansas, to annex said territory to the City of Eureka Springs, Arkansas and that said territory be designated as a part of Ward One (1) of said city.

NOW THEREFORE, BE IT ORDAINED by the City Council of the City of Eureka Springs, Arkansas;

SECTION I: That the City Council of the City of Eureka Springs, Arkansas, hereby accepts the annexation of the following described territory as a part of the City of Eureka Springs, Arkansas, as ordered by said County Court. That the annexed territory is more particularly described as follows, to-wit:

SE $\frac{1}{4}$ of Section 9, Township 20 North, Range 26 West, except that portion in the South part of the SW $\frac{1}{4}$ of the SE $\frac{1}{4}$ already annexed to the City of Eureka Springs.

SECTION II: That said annexed territory shall be designated as a part of Ward One (1) to the City of Eureka Springs, Arkansas.

SECTION III: That all ordinances or parts of ordinances conflicting with any provision of this ordinance are hereby repealed.
