

RESOLUTION NO. 593

**A RESOLUTION PROVIDING FOR AND ADOPTING BUDGETS FOR THE CITY OF EUREKA SPRINGS, ARKANSAS, FOR THE TWELVE-MONTH PERIOD BEGINNING JANUARY 1, 2012, AND ENDING DECEMBER 31, 2012; APPROPRIATING MONEY FOR EACH AND EVERY ITEM OF EXPENDITURE THEREIN PROVIDED FOR**

Whereas, the City Council of the City of Eureka Springs, Arkansas has made a comprehensive study and review of the proposed budgets: and

Whereas, in the opinion of the City Council, the proposed 2012 Budget presents as accurately as possible the City's anticipated revenues and expenditures for the 2012 calendar year;

**NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF EUREKA SPRINGS, ARKANSAS:**

**Section 1.** This resolution shall be known as the Budget Resolution for the City of Eureka Springs, Arkansas, for the twelve-month period beginning January 1, 2012, and ending December 31, 2012; and the attached 2012 Budget documents reflect estimated revenues and expenditures in detail for the period. All revenues and appropriations are based on estimated revenues; and all estimates are subject to change during the budgetary period.

**Section 2.** The amounts for revenues and expenditures proposed in the 2012 municipal budget are hereby authorized and appropriated for the purposes set forth the calendar year ending December 31, 2012.
