

**RESOLUTION NO. 612**

**A RESOLUTION AMENDING THE 2012 ADOPTED BUDGETS FOR THE CITY OF EUREKA SPRINGS, ARKANSAS, FOR THE YEAR 2012; APPROPRIATING MONEY FOR EACH AND EVERY ITEM OF EXPENDITURE THEREIN AND FOR OTHER PURPOSES**

**WHEREAS**, the City Council of the City of Eureka Springs, Arkansas has determined that it is in the best interest of the City to amend the adopted budgets of the City, and

**WHEREAS**, certain anticipated revenues and expenditures did not occur as previously budgeted.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF EUREKA SPRINGS, ARKANSAS, THAT:**

**Section 1:** This resolution shall be known as the Year End Amended Budget Resolution for the City of Eureka Springs, Arkansas, for the year 2012; and the attached 2012 Budget documents present the actual revenues, expenditures and appropriation adjustments for the period

**Section 2:** That the amounts for each expenditure classification in the amended budget are hereby approved by the City Council of the City of Eureka Springs, Arkansas; and they are hereby authorized and appropriated for the purposes set forth for the calendar year ending December 31, 2012:


