## 1. Discussion/acceptance of 2022 budget resolution

Mr. McClung moved to discuss. Ms. Greene seconded.

Finance Director Lonnie Clark confirmed the two requested adjustments were made. He identified the listing of Cemetery funds for a new building and summarized the bond payment schedule. He confirmed the 01 line items are the General Fund, and 00 are (non-departmental). Income accounts are listed as 4000's and expense accounts are 5000's. Mr. Clark noted ways in which enterprise funds stand alone.

Mr. McClung moved to assign the resolution a number and read it for passage. Mr. Meyer seconded. A roll call vote was taken.

Motion carried 6/0/0.

The Clerk Treasurer read resolution no. 816 A resolution providing for and adopting budgets for the city of Eureka springs, arkansas, for the twelve-month period beginning January 1, 2022, and ending december 31, 2022; appropriating money for each and every item of expenditure therin provided for.

#### 2. Discussion of bidding/selling piece of property on Main St.

The Mayor requested a motion to discuss selling a piece of property on Main St. Mr. Ott said he so moved. Mr. McClung seconded.

Mayor Berry spoke about a person who is building a home on Main St. and seeking to purchase the adjoining City-owned lots that abut. Mr. McClung favored going down to see the property. Mayor Berry assured Council there would be an appraisal and that he would provide the parcel number.
