## 1. Discussion of CAPC funds to assist in the Black Bass Dam project

Mr. Ott moved to discuss. Ms. Slane seconded. Ms. Slane provided and read a portion of A.C.A. 26-75-606 regarding use of City Advertising and Promotion funds on repair and maintenance of public recreation facilities and parks.

Discussion followed about not using A&P funds for capital improvements, the Basin Park bandshell repairs, advertising focused on the outdoors, and the expenditure decisions that are the Commission's to make.

Mr. Jacobi spoke about the dam as infrastructure.

Mayor Berry noted he had requested an opinion from a Municipal League Attorney.

#### **NEW BUSINESS**

## 1. Review of (Board of Zoning Adjustment) denial of rezoning request - 14 Washington

Mr. Meyer moved to discuss. Ms. Greene seconded. Mayor Berry summarized the report from the Board of Zoning Adjustment Chair, Ann Sallee, confirming the Board's unanimous vote to deny rezoning from R-1 to C-3.

Mr. McClung spoke about opposing spot zoning. Following discussion of objections from neighboring property owners, Mr. Meyer moved to deny (re-zoning). Ms. Greene seconded. The process outlined in Code was discussed and Ms. Greene withdrew the second with a request for Mr. Meyer to withdraw the motion.

Mr. Meyer moved to affirm the decision of the (Board of Zoning Adjustment). Ms. Greene seconded.

Motion carried 6/0/0.

### 2. Resolution for Black Bass Dam

Mr. Meyer moved to discuss. Mr. McClung seconded. Mayor Berry confirmed the fiscal cycle for FEMA (Federal Emergency Management Agency) grants ends June (30). Submitting the proposal before the end of the month would allow it to be within their 2022 budget. The resolution was prepared to waive bidding for stonework to repair the dam.

Mr. Ott moved to give the resolution a number and have it read into the record. Ms. Greene seconded. Discussion included contract documents yet to be prepared, time that approval from the State has taken, and where the stones would be stockpiled.

A roll call vote was taken.

Motion carried 6/0/0. RESOLUTION NO. 820 A RESOLUTION TO AUTHORIZE THE MAYOR AND PUBLIC WORKS DEPARTMENT TO WAIVE BIDDING IN THE REPAIR OF BLACK BASS DAM was read.
