REGULAR MEETING

APRIL 27, 2020

Mayor Robert "Butch" Berry called the regular meeting of the Eureka Springs City Council to order at 6:00 p.m. Monday, April 27, 2020 in the Court Room of the Western District Court House at 44 S. Main.

PRESENT in person: Mayor Berry, Council members Melissa Greene, Terry McClung, Bob

PRESENT remotely: Council member Mickey Schneider and City Attorney Tim Weaver

PLEDGE OF ALLEGIANCE:

Mayor Berry led the Pledge of Allegiance.

APPROVAL OF THE AGENDA:

Ms. Harman moved to approve the agenda. Mr. McClung seconded. New Business item 1 was removed and item 3 was postponed until the May 11 meeting. Approval of the amended agenda was by roll call.

Motion carried 6/0/0.

APPROVAL OF THE MINUTES: April 13, 2020

Mr. McClung moved to approve. Ms. Greene seconded. A voice vote followed. Motion carried 6/0/0.

ARBOR DAY PROCLAMATION:

Mayor Berry read a proclamation acknowledging Arbor Day and Eureka Springs' 38 year of being a Tree City U.S.A., the oldest in the State.

2. Raymond James bond refinancing proposal

Ms. Green moved to discuss. Ms. Harman seconded. The summarized proposal was provided. Finance Director Lonnie Clark said \$83,274 will be saved by refinancing and realized in 2020. The current proposal included a payoff date of October 2027.

Ms. Harman moved to accept the proposal from Raymond James on (refinancing the tax bond.) Ms. Greene seconded. A roll call vote followed.

4. Update on the Eureka Springs Economic Task Force

Ms. Greene moved to discuss. Mr. McClung seconded. Mayor Berry spoke about Monday, Wednesday and Friday meetings to develop standards for reopening businesses. He noted the Corona Virus update page on the City website and referenced almost daily "Zoom" meetings for statewide information from the Governor's office.

AGENDA SETTING:

Mr. McClung recalled agreeing to have a 5:00 budget workshop before the May 11 meeting.

CITY COUNCIL COMMENTS:

Mr. Thomas spoke about the advice, "Hope for the best and plan for the worst."

Ms. Greene reflected on the optimism being shown, and the need to develop ways to make lodgings safe.

Ms. Harman said she continues to pray, and said that people need to know dates when businesses can restart.

Mr. McClung encouraged people to get involved with helping others, to do what they can.

Mr. Meyer spoke about the risks now taken by those who ring up and bag groceries every day.

Ms. Schneider rued not being able to hug loved ones and sent best wishes for staying safe.

MAYOR'S COMMENTS:

Mayor Berry expressed his belief that, in the next few weeks, more will be known about dates for opening facilities. He noted the Economic Recovery Task Force (comprised of representatives from lodging, restaurants, retail, economic development, parks, banks, CAPC and the Chamber) is helping to develop a timeline. Updates are posted on the City web site.

Mr. McClung moved to adjourn. Ms. Greene seconded. Motion carried 6/0/0. The meeting ended at 6:30 p.m.
